



Terms & Conditions “Bet R30 get R30”

1. In order to qualify for the promotion, the customer must bet **R30 on any sports game** (lotto not included). The customer must then send an email to **support@firstbet.co.za** with the subject “**Bet30Get30**” and include the **cellphone-number** they registered their account with.
2. Offer valid only to customers making their first deposit of R30 or more and make a qualifying bet in accordance with the Free Bet Specific Terms and Conditions.
3. The promotion is limited to new customers only and is available once per a customer/ account/ IP address.
4. Max. Free Bet amount is R30 and minimum deposits and wagering on sport to activate the Free Bet is R30. Void/cancelled or cashed out bets do not count towards wagering to activate the free bet.
5. The customer’s account will be credited with the R30 bonus within 2 business days from the time they bet at least R30 on a sports game.
